Unique Lateral Cage Treats Degenerative Disc Disease and Instability Through a Minimally Invasive Approach

Implanted through a minimally invasive lateral approach with dedicated instrumentation, the LLC was designed for the treatment of degenerative disc disease and instability, including grade 1 spondylolisthesis or retrolisthesis. The LLC features a unique locking design that rigidly fastens the cage to the lumbar vertebra, and offers a variety of implant sizes to accommodate a wide range of patient anatomy and pathology.

"The combination of the LLC and Zimmer Spine's PathFinder NXT® Minimally Invasive Pedicle Screw System provides surgeons with a complete minimally invasive approach, offering potentially faster surgeries and shorter hospital stays.
